*** The DVHS exemption applies only to the immediate living area of the taxpayer's homestead, however, if a taxpayer qualifies for a DVHS they most likely also qualify for the DV4 exemption, and therefore, can apply the DV4 additionally to other taxable property owned by the taxpayer. Qualification for the DVHS is based on an award letter received from the VA, stating that the taxpayer is both 100% disabled and unable to work.
